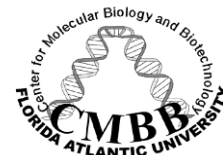


BIOTECHNOLOGY CERTIFICATE PROGRAM



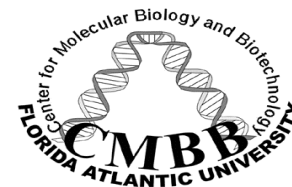
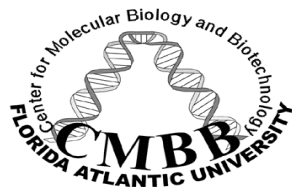
The Biotechnology Certificate Program is open to all FAU Biology and Chemistry Students with a GPA of 2.5 or higher and all students with a Bachelors degree in Biology or Chemistry regardless of the institution. Students in other departments who feel they may have, or will have, equivalent academic experience should contact Dr. Binninger, SC 210, (561) 297-3323 or Email address: binninge@fau.edu. There are no fees or charges associated with this program above those for normal class registrations.

This program is designed to encourage and recognize students preparing for a career in biotechnology. In addition to the requirements for the bachelors' degree sought, students must complete the following courses, or the equivalent with the indicated minimum grade.

MCB 3023 -- General Microbiology -- (3 credits)	C-
MCB 3023L-- General Microbiology laboratory -- (1 credits)	B-
BSC 4403L -- Biotechnology I laboratory -- (2 credits)	B-
BSC 4405L -- Biotechnology II laboratory -- (2 credits)	B-
BCH 3103L-- Biochemistry laboratory -- (3 credits)	B-
PCB 4522 -- Molecular Genetics -- (4 credits)	C-

Once registered, students will remain registered for 2 years or until they graduate. Students in the Biotechnology Certificate Program are encouraged (but not required) to attend seminars in Biotechnology. Students who complete the Program requirements with an overall GPA of at least 2.5 and meet the grade requirements for the six courses listed above can apply to the Biotechnology Program for a Biotechnology Certificate. Completion of the Biotechnology Certificate program will be indicated on the student transcript and the Biotechnology Program will issue a Certificate.
